

## RELEASE FROM LIABILITY AND AGREEMENT

In consideration for my acceptance at the 2023 Pacific Northwest Muay Thai Camp (referred to as "Event"), I do hereby voluntarily submit my application for attendance and participation August 2 through August 5, 2023 at the Camp Wilkerson in Rainer, Oregon.

**ASSUMPTION OF RISK.** I AM AWARE AND UNDERSTAND THAT, IN GENERAL, MARTIAL ARTS IS A DANGEROUS AND HAZARDOUS ACTIVITY, AND IN PARTICULAR, THE EVENT, OR TEST, IN WHICH I AM PARTICIPATING INVOLVES EXTREMELY DANGEROUS AND HAZARDOUS PERFORMANCE. I AM VOLUNTARILY AND OF MY OWN FREE WILL PARTICIPATING IN THE EVENT WITH FULL KNOWLEDGE AND UNDERSTANDING OF THE SERIOUS DANGER AND HAZARDS INVOLVED. I HEREBY CONSENT AND AGREE TO COMPLETELY ACCEPT ALONE ANY AND ALL RISKS OF INJURY OR DEATH, AND I VERIFY AND CONFIRM THIS STATEMENT BY PLACING MY INITIAL HERE: \_\_\_\_\_.

**Release.** In consideration for being permitted by the World Thai Boxing Association and/or Event Sponsors (Event Sponsors refers to any and all instructors, test team, camp coordinators, employees, operators, or agents, collectively) to participate in the Event, and in consideration for being permitted to use the Event's facilities in connection with the Event or Test, I hereby agree that I, my heirs, distributees, guardians, successors in interest and legal representatives (collectively referred to as "Releasor") will not make a claim or file an action or suit against, sue, or attach the property of the Event Sponsors, Test Team, Instructors, and/or any of their respective affiliated organizations, shareholders, directors, officers, employees, agents or members of the Event Sponsors, and/or their respective affiliated organizations (collectively referred to as "Releasees"), for damages, injury, emotional distress claims, bodily injury claims, and punitive damages, whether known or unknown, foreseen or not, due to or resulting from the acts, conduct, negligence, or misfeasance of, or omissions or failures to act by the Event Sponsors.

**Application of California Law.** In further consideration of (a) being permitted to participate in the Event or Test, and (b) being permitted to use any of the Event's facilities and equipment, I hereby agree that this Release from Liability shall be interpreted under and construed in accordance with California law only, without the benefit of and fully disregarding all California conflicts of laws provisions, so that any and all disputes, contentions, disagreements or controversies arising from or related to (a) this Release from Liability, (b) my participation in the Event or Test, or (c) my use of the Event's facilities and/or equipment, shall be interpreted under and in accordance with only California law regardless of my domicile or residency; and that the only court in which an action or suite may be brought in connection with the foregoing shall be the court of original jurisdiction of the State of California situated in the County of Los Angeles. Further, I waive any right I may have to assert the doctrine of forum non conveniens or similar doctrine or to object to venue with respect to any proceeding brought in accordance with this Release, and I stipulate that the California courts shall have in personam jurisdiction and venue over me for the purpose of litigating any dispute, controversy, or proceeding arising out of or related to this Release and the Event Sponsors or Test Team.

**Health Advisory and Condition.** I hereby acknowledge and understand that participation in the Event or Test involves extremely strenuous physical performance, and that I have advised to consult a physician before commencing and undertaking such activity. I hereby represent that, to the best of my knowledge, I am in good physical health and condition, sufficient to undertake the activities and practices required during the Event or Test.

**Responsibility for Damage.** I hereby agree and assume full responsibility for any and all damages and losses whether intentional or accidentally, caused to the Event by me and will be responsible for payment to the Camp in full for such damage.

**Consent.** I hereby agree and consent that any pictures or video-taping requires permission prior to taking any and all video footage/pictures at camp, and copies provided to WTBA that may be used for publicity, promotion, or television showing, and I waive compensation in regard thereto.

**Knowing and Voluntary Execution.** I hereby declare that I have carefully read this Release from Liability and Agreement, and that I fully understand the meaning and importance of its contents. I acknowledge that I am releasing the Event Sponsors or Test Team from all liability for claims I may have against them.
